1 **4. Findings**

2 **Authority:** The court has jurisdiction over the parties and the subject matter.

3 **Notice:** The Restrained Person had reasonable notice and an opportunity to be heard.
4 They were notified of the hearing by personal service

5 The Restrained Person was present at the hearing.

6 ~~Credible Threat: The Restrained Person represents a credible threat to the physical safety of
the Protected Person. 7.7.7.~~

7 **Intimate Partner:** The Restrained Person and the Protected Person are/were intimate partners
8 because they are:

9 parents of a child-in-common (unless a child was conceived through sexual assault).

10 **5. Court Orders to the Restrained Person listed in 1:**

11 **Warning!** You **must** obey this order until it ends. If you know about this order but do not
12 obey, you may be arrested and charged with a crime.

13 **Do not disturb**

Do not disturb the peace of the Protected Person.

14 **Stay away**

15 Do not go onto the grounds of or enter the Protected Person's home, workplace or vehicle
(With the exception of transferring the children for visits pursuant to the existing parenting
16 plan entered on 12/20/2019.)

17 **Do not hurt or threaten**

18 **Warning!** If the court checks this box, the court must consider if weapons restrictions are required by
state law; federal law may also prohibit the Restrained Person from possessing firearms or ammunition.

19 Do not:

- 20 • Assault, harass, stalk, or molest the Protected Person 2; or
21 • Use, try to use, or threaten to use physical force against the Protected Person that
would reasonably be expected to cause bodily injury.

22 **6. Washington Crime Information Center (WACIC) and Other Data Entry**

24 This agency shall enter this order into WACIC and National Crime Info. Center (NCIC).

1 **7. Service**

2 **Required.** The Restrained Person must be served with a copy of this order.

3 **Important!** The Protected Person has a right to have law enforcement serve this
4 order free of charge if the "Do not disturb," "Stay away," "Do not hurt or threaten," or
"Prohibit weapons and order surrender" boxes are checked above.

5 The law enforcement agency where the Restrained Person lives or can be
6 served shall serve the Restrained Person with a copy of this order and shall
promptly complete and return proof of service to this court.

7 Law enforcement agency: Spokane County Sheriff's Office

8 **Clerk's Action.** The court clerk shall forward a copy of this order on or before the next
9 judicial day to the agency and/or person checked above. The court clerk shall also
provide a copy to the Protected Person.
